### How will the package be implemented?

These are the core factors that deliver such a light & flexible footprint for small business

- Business Central can be licensed as a subscription or an on premise option, where you own the license.
- Business Central can be hosted on the cloud or on your server
- Business Central Subscription is a month-to-month subscription-based licence. This delivers an effective method of managing your software costs against your cash flow.
- Subscription based licensing has a No lock-in contract. That's right, in the event that your circumstances change which force you to leave the subscription, there are no penalties applied. This provides a low risk approach to small business software licensing.
